Blakely-Early County Chamber of Commerce presents Christmas on the Square on Saturday, December 10, 2022 on the Courthouse Square in Blakely, Georgia. Events are scheduled from 11:30 AM until AFTER PARADE This is an outdoor show. Exhibits are set up around the Courthouse Square on the sidewalk and street. No exhibits on grass. Traffic is closed around the Square. Exhibitors must provide sturdy display material and must be prepared for wind or rain. Tables and displays are not furnished. No Rain Date / All fees are non-refundable.

Arts and Crafts: Artwork, Crafts, handcrafted items, woodworking, carving, folk-art, etc.

Food Booths — Limited: You are encouraged to submit your application as early as possible. First come, first served

Commercial Booths: Businesses are encouraged to promote their product in a professional manner, Example: You may display/sell grills, toys, go-carts, fishing equipment, hunting supplies, farm equipment, new cars and trucks.

Booth Spaces: The booth spaces are approximately 12' by 12' deep. Please do not set up anything on the grass due to underground wires. All entrants are expected to bring their own display units, materials, tables, chairs, tents, panels, cover, etc. Limited electricity will be available for some booths, but you must apply in advance. You will be responsible for keeping your area clean during and after the festival.

TWO OPPORTUNITES TO REGISTER: Upon arrival in Blakely, please check in at the Chamber of Commerce, 214 Court Square. Check-in times are either Friday, December 9th from 5:00 PM — 6 PM (You can check in on Friday night, but will not be able to set up in the space that is assigned) until Saturday, December 10 from 7:00 AM — and ready by 11:00 AM.

Or you may register on Saturday from 7A.M. – 10 A.M. and be completely setup by 11:00 A.M.

The Christmas on the Square Festival reserves the right to make final interpretation of all rules. Sponsor may prohibit items that are deemed in bad taste. An application is a commitment to show. No refunds will be made for cancellation or removal for cause. In the event of unforeseen circumstances, the show may be terminated at the discretion of the Chairman. Food wagons must be neat, presentable (fully painted) and clean or they will not be allowed to set up. Food vendors must also place some type of ground cover (ex: cardboard) under the cooking equipment to prevent splatters on the sidewalk or street. There will be absolutely nothing set up on the grass.

No pets or sound equipment, such as radios or stereos, are allowed in any exhibit area. No bicycles or skateboards.

No alcoholic beverages are allowed.

Application deadline is November 25, 2022. Applications must be received by this date. If an application comes in late and is accepted, a late fee of \$25.00 will be charged for applications received after the deadline. The application must be accompanied by a check or money order made payable to "Christmas on the Square."
